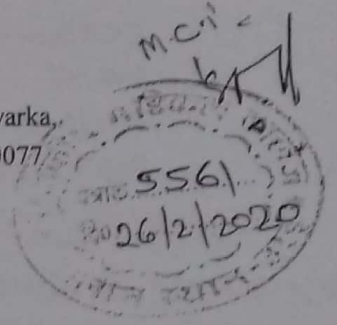

Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the compliance verification assessment report (27th August, 2019) with regard to Recognition/Approval of Manyavar Kanshiramji Govt. Allopathic Medical College, Jalaun (Orai), Uttar Pradesh for the award of MBBS degree (100 seats) granted by King George's Medical University, Lucknow u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 23rd January, 2020. The compliance verification assessment report (23rd January, 2020) alongwith the summary/observations of the Member of the Undergraduate Expert Group appointed by the Board of Governors was considered by the Board of Governors and it was decided to recommend to the Central Government for recognition/approval of Manyavar Kanshiramji Govt. Allopathic Medical College, Jalaun (Orai), Uttar Pradesh for the award of MBBS degree (100 seats) granted by King George's Medical University, Lucknow u/s 11(2) of the IMC Act, 1956.

The Board of Governors further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."
