I am directed to refer to MCI's letter No. MCI-34(41)(R-74)/2017-Med/107483 dated 30.04.2017 on the subject mentioned above and to convey the approval of the Central Government for renewal of permission for admission of 5th Batch (100 seats) of MBBS students for the academic year 2017-18 at Manyavar Kanshi Ram Ji Govt. Allopathic Medical College, Jalaun, Orai now known as Rajkiya Govt. Medical College, Jalaun, Orai under Chhatrapati Shahuji Maharaj Medical University, Lucknow.

2. The permission is valid for one year and for admitting only one batch of 100 MBBS students during the academic session 2017-18. The next batch of students in MBBS course will be admitted in the college only after permission of Central Government for renewal/recognition.
3. The Government Medical College (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
4. Admissions made in violation of the above conditions will be treated as irregular and action will be initiated under IMC Act & Regulations made thereunder.
5. Discrepancies, if any, may be immediately brought to the notice of MCI and the Central/State Government.
